## Mission Statement

The mission of the Lowell Police Department is to continue building and maintaining strong partnerships with the diverse communities of the city of Lowell. We strive to work with our community to reduce the incidence and fear of crime, and to ensure public safety. We will do this while working to improve the quality of life for the citizens of Lowell.

The Lowell Police Department is committed to the ideals of Community Policing. Those ideals are evident in programs such as the Citizens Police Academy, the Police Volunteer Program and the Community Relations Council. The Department's core values are integrity, respect, accountability, community, sanctity of life, and knowledge. Patrols are assigned by geographic sector, encouraging officers to become intimately associated with neighborhoods and their residents, better enabling them to fight and prevent crime.

## Highlights

- ◆ LPD participated in the Light It Up Blue campaign to celebrate World Autism Awareness Day.
- ◆ The department created an 8 AM Routine on social media to remind residents to practice social distancing and created interactive activities with the community. The department continues to post the 9 PM Routine reminder on a regular basis.
- ◆ Superintendent Richardson released a statement to the community denouncing the actions and inactions of the offices involved in the tragic death of George Floyd. LPD policies on Use of Force and Duty to Intervene are briefly discussed on page 4.
- ◆ Individuals and community organizations made donations to the LPD during the COVID-19 pandemic.

## World Autism Awareness Day

The LPD recognizes World Autism Awareness Day every year by participating in the Light It Up Blue campaign. On April 2nd, the LPD had police officers pull over to the side of the road and activate the lights in their cruisers for 60 seconds. Unfortunately, the Autism Awareness Resource Fair was cancelled due to the pandemic. Please stay tuned for additional information.

The Lowell Police Department implemented the Safe Watch Program in 2019. The LPD Safe Watch Program allows residents to enter information about their loved ones with a disability or another condition that can enhance the tendency to wander from safe environments. Information, such as physical characteristics or favorite locations, can then be used to immediately begin a search in the event that an individual goes missing. ## LPD 8 AM Routine

The LPD started an 8 AM routine to remind residents to practice social distancing and to avoid large crowds. The department also made suggestions for activities that residents could do in their free time, such as video chatting with friends and family. These types of activities can allow residents to remain in contact with friends and loved ones and can reduce feelings of isolation during the pandemic. Residents were encouraged to participate in a “Chalk Your Walk” challenge and submit pictures of their pets, which were shared on social media. The LPD continues to post its 9 PM routine on Twitter and Facebook. The 9 PM Routine is a daily reminder to residents to remove or hide all valuables in their cars and to lock their doors at night.

Dear Community Members:

Most have seen the disturbing video of the tragic death of George Floyd in Minneapolis. The Lowell Police Department (LPD) stands with the public in denouncing the actions and inaction of the officers involved. ## Lowell Police Officer Training Standards and Department Practices

- Police officers at the LPD attend the Lowell Police Academy prior to becoming a sworn officer. After attending the academy, officers familiarize themselves with the LPD policies, procedures, rules and regulations. Officers also receive on-the-job training and are assigned to a Field Training Officer. After completing their initial training, officers must attend in-service trainings on a regular basis. These trainings are to ensure that LPD officers are familiar with current policies and procedures.
- Use of Force Policy: Police officers are authorized to use lethal force in order to protect him or herself, another officer, or another person when the officer has a reasonable belief that an imminent threat of death or serious bodily injury exists. Officers must take into consideration the severity of the crime, whether a suspect poses an imminent threat to the officer or others, and whether the suspect is actively resisting arrest or attempting to evade arrest. In the event that a police officer must use force on an individual, the event must be reported.
- Duty to Intervene: LPD officers have a duty to intervene when force from another officer is being unreasonably applied or is no longer required. Any intervention is later documented. Police officers also have a duty to report offenses and violations of the rules and regulations by officers and other employees.



## LPD's Relationship with the Community

The Lowell Police Department works diligently to maintain its strong relationship with the community. This can be seen through the community and neighborhood association meetings as well as the department's participation in community programs and events. Unfortunately, many of these events have been canceled or postponed due to the COVID-19 pandemic. The neighborhood meetings and community events will continue as soon as it is safe to do so. The LPD also collaborates with many community organizations such as the Boys and Girls Club of Greater Lowell, YWCA of Lowell, Lowell Community Health Center, and YouthBuild to create and fund programs for youth in the city.
